



COPYRIGHT POLICY

As a part of its mission, the NPUAP produces a number of materials that are designed to enhance education, research, public policy, and/or clinical practice related to pressure ulcers. These materials remain the collective intellectual property of the NPUAP.

NPUAP copyrighted materials can be used free of charge for non-profit purposes involving education, research, policy, and/or clinical practice unless explicitly stated otherwise. Users of NPUAP materials in these instances are only required to acknowledge the NPUAP and the “version number” of the NPUAP material on any hard-copy or electronic reproduction. As the NPUAP often likes to track the use of its material and therefore requests a copy of the finished publication. Non-profit users are free to alter or modify any NPUAP materials. However, the NPUAP should be cited as the original source and the modifications acknowledged.

For written publications, the following statement is required to appear in a prominent location within the document: “Reproduction of the National Pressure Ulcer Advisory Panel (NPUAP) materials in this document does not imply endorsement by the NPUAP of any products, organizations, companies, or any statements made by any organization or company.” For electronic publications, such as Power Point® presentations, the above statement must appear in at least one location in the publication. Further, NPUAP logos that may appear in NPUAP copyrighted photos or images must not be removed when they are included in a for-profit user’s publication. The care of patients in “for profit” health care facilities is exempt from these restrictions on the use of copyrighted NPUAP material. A sample copyright license that will usually be required is included in Appendix A.



COPYRIGHT LICENSE

The National Pressure Ulcer Advisory Panel, referred to as COPYRIGHT HOLDERS, and _____, referred to as LICENSEE agree:

WHEREAS, COPYRIGHT HOLDERS, are the owners of the following described item:

The PUSH Tool, etc [name material], Copyright issued on September 15, 1998

And, WHEREAS, the LICENSEE desires to obtain a non-exclusive license to use the copyrighted material, IT IS AGREED:

That COPYRIGHT HOLDERS grants to LICENSEE the non-exclusive right to manufacture, sell, and otherwise use and practice the above stated material throughout the world. This license shall apply to any extension or re-issue thereof.

LICENSEE shall pay a one-time fee of \$100.00. The LICENSEE agrees to use the {name material] without abridging or changing the wording or scoring of the tool. The full name of the [material] must be used in the materials and the copyright should be acknowledged by including this phrase on all reprints/images of the [material] (Copyright. National Pressure Ulcer Advisory Panel, 1998. Reprinted with permission.)

COPYRIGHT HOLDERS shall provide reasonable cooperation and assistance to LICENSEE as to the practice and use of the copyrighted material.

This license may not be assigned or transferred by LICENSEE, except with the prior approval of COPYRIGHT HOLDERS, which shall not be unreasonably withheld.

Upon any default herein, the COPYRIGHT HOLDERS may terminate this contract after 15 days notice of the breach. The LICENSEE shall notify COPYRIGHT HOLDERS immediately as to any copyright infringement of which LICNESEE may become aware of from time to time.
