Hopefully everyone experienced a wonderful summer and is refreshed once again. As fall approaches, conference, meeting and continuing education events occupy our time and attention. So it goes with the work of the National Pressure Ulcer Advisory Panel... however the summer presented us with a continuing busy and productive schedule.

The Support Surface Initiative Group has been busy working on their initiative and plans another meeting in conjunction with MedTrade in Atlanta in early October. Exploration of grant monies continues. The Deep Tissue Injury Task Force has a manuscript ready to submit for publication. The Public Policy committee and other interested Panel members have been critiquing and providing input related to the CMS work on section M of the Minimum Data Set. Educationally, four upcoming conferences are planned. Two one-day conferences were held in Reading, PA on September 19-20 on "Best Practices for Assessment & Treatment of Pressure Ulcers," and "Avoidable vs. Unavoidable Pressure Ulcers: What is the Evidence?" The "Best Practices" conference will also be held on October 31 in Des Moines, IA. NPUAP is sponsoring a half-day pre-conference October 16 on "Minimizing Litigation in Pressure Ulcer Care" in conjunction with the Clinical Wound Symposium in Chicago, IL. Lastly, a one-day conference will be held at the LaGuardia Marriott

in East Elmhurst, NY on November 21 on "Best Practice in Assessment & Treatment of Pressure Ulcers: Clinical, Regulatory & Legal Perspectives." NPUAP will co-sponsor a one-day conference in Ft. Myers, FL on January 22, 2004. This focus will be "Minimize Litigation in Pressure Ulcer Care". More info will be available soon.

NPUAP is extremely pleased to be working on the expansion of the Provider Council and the Collaborative Organization Council, as well as the Corporate Advisory Council. Talks are underway with interested organizations, providers, and companies and we look forward to our expanded memberships. The organization is as good as the sum of the parts!!

Support Surface Standards Initiative

The NPUAP Support Surface Standards Initiative (S3I) will hold its second working group meeting of the year on October 8th at MedTrade in Atlanta, GA. For information on the meeting or an update on current progress contact Laura Markusson at lmarkusson@drohanmgmt.com. Meetings are open to all interested participants. If you are a new participant and plan to attend a meeting, please let us know so that we may plan accordingly.

S3I has three working groups, Lifespan Evaluation, Tissue Integrity Management, and Terms and Definitions. The working groups are developing documents and test methods that will eventually form the basis of new voluntary standards for support surfaces. S3I has recently contacted RESNA (The Rehabilitation Engineering and Assistive Technology Association of North America) to investigate the feasibility of collaborating on the initiation of a Preliminary Work Item proposal to the International Organization of Standardization (ISO). If accepted, the ISO effort will require worldwide participation. Such an international effort will facilitate the harmonization of national and international standards. 🌱

Report on the European Pressure Ulcer Advisory Panel Conference in Tampere, Finland September 3-6, 2003

An exciting, educational, and fun-filled conference was hosted by EPUAP in Tampere, Finland September 3-6. The theme was "Pressure Ulcer Prevention and Management – Have We Made A Difference?". Presentations focused on work that has been done throughout Europe over the past several years. The new Guideline on Nutrition in Pressure Ulcer Prevention and Treatment was presented and generated much discussion. The guideline has many similarities to the AHCPR Guidelines related to nutrition here in the US. Risk Assessment Scale – Old Ideas and New Challenges, Pressure Ulcer Prevention in Home Care, studies on bed management and mattress management programs were presented, and another on Comparing Interface Pressure Between Volunteers and Patients Measured on the Same Type of Support Surface were very interesting. A large poster display afforded the attendee exposure to many of the latest studies related to pressure ulcer prevention and treatment.

A reception was hosted by the conference committee and city of Tampere at the Old City Hall to open the conference, while the second evening found us being entertained and fed at the original Tampere Dock House. The Gala dinner and entertainment the last evening was Finnish throughout, with reindeer as the entrée, Finnish dancers and singers, and an evening of dance enjoyed by hundreds.

Coming from the Eastern North Dakota/northern Minnesota area and knowing many Fins in our area, it became obvious why many Fins settled in this area...the landscapes look so similar! This was a wonderful opportunity to collaborate and network with so many European leaders!

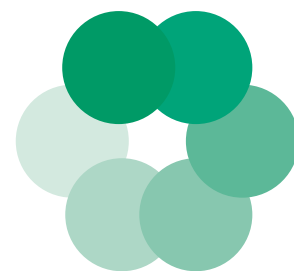
